NURSERY ADMISSIONS JUNE -2020
(Only open to Property Owners of Magarpatta City)

1. This Notice deals only with Nursery Admission. Admission for classes LKG to Std.VII will be considered ONLY after 10.05.2020, And ONLY IF VACANCIES EXIST. Admissions will be in accordance with the Maharashtra Right of Children to Free and Compulsory Education Rules 2011.
The Age Limits for the Nursery Class is between 3 and 4 years as on 30.09.2020.
2. This is an ICSE School and the number of Children in each classroom is restricted to 45.

The Total No of Seats available in the Nursery are 135. There are:

a) Seats Reserved under the RTE Act by the Government	34
b) Open Seats only for Property Owners and Share Holders in MTD&C Company Ltd.	75
c) Seats Reserved by the Management for Children of Teachers, serving in V.P. Magarpatta City Public School, Employees of Magarpatta T.D.& C. Co. All Such cases will be considered at the discretion of the Management.	26

3. The Property Owners of Magarpatta City are given the First Preference for all Open Seats. This is because the Property Owners of Magarpatta City have paid Advance Maintenance Charges to Magarpatta City Township Development and Construction Company. This amount has been utilized for the construction of the School Building as well as the other Facilities and Services available for their convenience and enjoyment.
4. REGISTRATION FOR ADMISSION TO THE NURSERY FOR 2020-21 WILL TAKE PLACE IN THE MAIN SCHOOL (OPPOSITE DESTINATION CENTRE) ON SATURDAY, 18.01.2020 FROM 11:00 a.m. to 1:00 p.m. AND AGAIN ON MONDAY, 20.01.2020 AND TUESDAY, 21.01.2020 FROM 4:30 p.m. to 5:30 p.m. The Non Refundable Registration Fee is Rs.100/-,(Rupees One Hundred only).

ONLY CHILDREN OF PROPERTY OWNERS ARE ELIGIBLE FOR ADMISSION TO THE 75 OPEN SEATS. PROPERTY OWNERS CANNOT SEEK ADMISSION FOR CLOSE RELATIVES LIKE GRANDCHILDREN IF THEY ARE NOT RESIDING WITH THEM. THEY WILL HAVE TO PRODUCE AN AFFIDAVIT IN CASE THE GRANDCHILDREN OR CLOSE RELATIVES ARE STAYING WITH THEM.

5. THE LUCKY DRAW WHICH CONFIRMS THE ADMISSION AND IS COMPULSORY UNDER THE RTE ACT WILL BE HELD ON MONDAY 03.02.2020 AT 4:30 p.m. IN THE MAIN SCHOOL.

Parents, whose Children have got admission through the Management Quota, cannot seek an admission for another sibling under the Seats reserved for Property Owners.


6. Please note that the School cannot admit students having Special Medical Problems which require Special Schools and Specially Trained Teachers and Assistants.
7. At the Time of Registration the Parents must produce:
- The Aadhaar Cards of both the Parents. The Child's Aadhaar card is to be produced before School reopens on 01.06.2020
 - The Original Birth Certificate of the Child and a Copy of the same. THE CHILD'S NAME MUST BE SHOWN IN THE BIRTH CERTIFICATE.
 - A Certificate from the Senior Vice President (Administration) of Magarpatta City that the Parent is a bonafide Property Owner of Magarpatta City.
 - The Total Yearly Fees for the Nursery are:

1) Admission Fee	₹	1,000.00

The payment for the Fees can be made through Demand Draft payable to V P Magarpatta City Public School.
